CLEANSING NOTICE UNDER SECTION 708A

Horizon Minerals Limited (ASX: HRZ) (the "Company") announced on 13 August 2020¹, that it will issue 115,000,000 fully paid ordinary shares at \$0.14 per share through a Placement to sophisticated investors and professional investors raising \$16,100,000.

Settlement of the Placement will occur in two tranches:

- Tranche 1, the Company has issued 57,500,000 million Placement Shares (A\$8.05 million) pursuant to Listing Rules 7.1 and 7.1A. No shareholder approval is required for the issue of shares in Tranche 1; and
- Tranche 2, which is subject to shareholder approval at a General Meeting to be convened in September 2020, comprises the issue of a further 57.5 million Placement Shares (A\$8.05 million).

- (a) the Placement Shares will be issued without disclosure to investors under Part 6D.2 of the Corporations Act;
- (b) this notice is being given under section 708A(5)(e) of the Corporations Act;
- (c) as at the date of this notice, the Company has complied with:
 - (i) the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and
 - (ii) section 674 of the Corporations Act; and
- (d) as at the date of this notice, there is no information that is 'excluded information' within the meaning of sections 708A(7) and 708A(8) of the Corporations Act.
